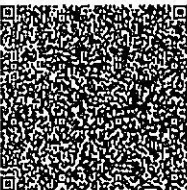
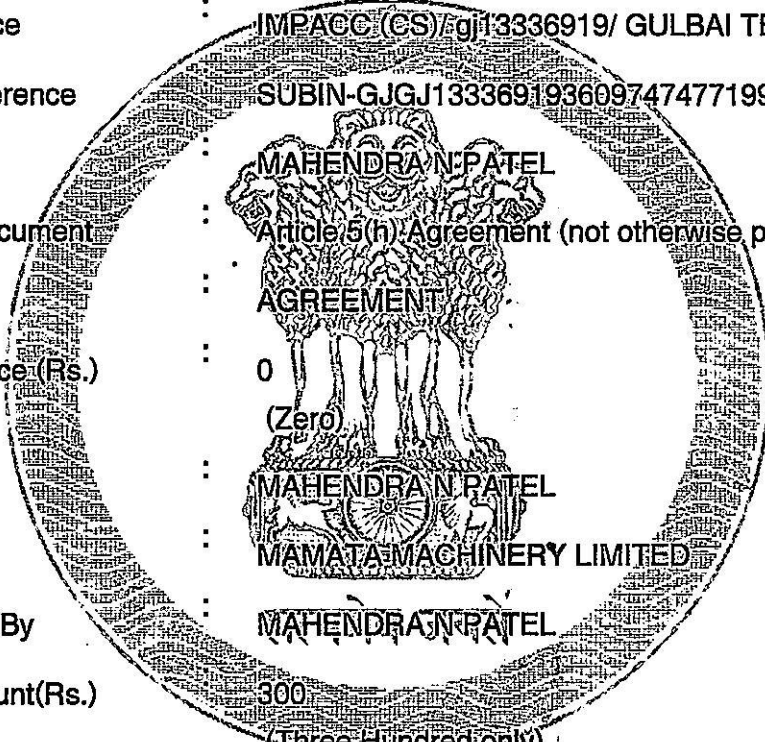

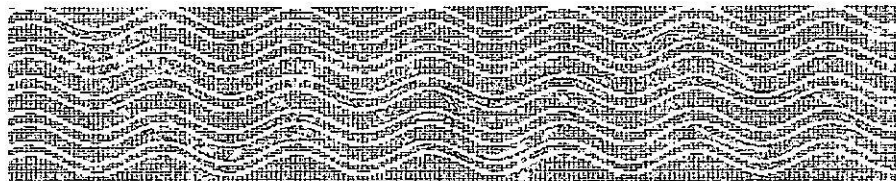

SUPPLEMENTARY TRADEMARK LICENSE AGREEMENT

This Agreement dated this 9th day of September, 2024 by and between Mr. Mahendra N. Patel, Indian, Adult, Aged 75 years, residing at 12/A, Kairvi Bungalows, Near Sarthi Hotel, Vastrapur Road, Bodakdev, Ahmedabad – 380054 (hereinafter referred to as "Licensor", which expression shall mean and include his legal heirs and legal representatives) of the ONE PART;

AND

M/s. Mamata Machinery Limited (formerly known as Mamata Machinery Private Limited), a Company incorporated under the provisions of erstwhile Companies Act, 1956 and now governed by the provisions of the Companies Act, 2013 having its registered office at Survey No. 423/P, Sarkhej-Bavla Road, Moraiya, Sanand, Ahmedabad - 382213 (hereinafter referred to as "Licensee" which expression shall mean and include its successors and assigns) OF THE OTHER PART.

LICENSOR and LICENSEE are hereinafter individually referred to as "party" and collectively as "parties".




WHEREAS

LICENSOR and LICENSEE had entered into a "Trademark License Agreement" dated June 29, 2021 whereby the LICENSOR had granted permission to the LICENSEE to use the Trademark registered in the name of the LICENSOR details of which have been attached as Schedule – I to the original Agreement dated June 29, 2021.

Further the LICENSOR had vide his letters dated 23rd March, 2022, 1st April, 2022 and 1st April, 2023, waived off License Fee payable by the LICENSEE to the LICENSOR for the period from 1st July, 2021 till 31st March, 2025.

With reference to the above waiver it was further agreed between the parties as follows:

1. With reference to Clause 2.3 of the Trademark License Agreement and the fee waiver letters issued by the LICENSOR, it is hereby agreed that the LICENSOR will not charge the LICENSEE any consideration even after 31st March, 2025 and in case, LICENSOR intends to charge such consideration in future, it will be subject to the shareholders approval of the LICENSEE even if such approval is not required to be taken as per the provisions of the Companies Act, 2013, SEBI (LODR) Regulations, 2015 and any other applicable rules and regulations.

2. All other definitions, interpretations, terms and conditions and obligations shall remain the same and shall construe the same meaning as contained in the original Trademark License Agreement dated June 29, 2021.


